

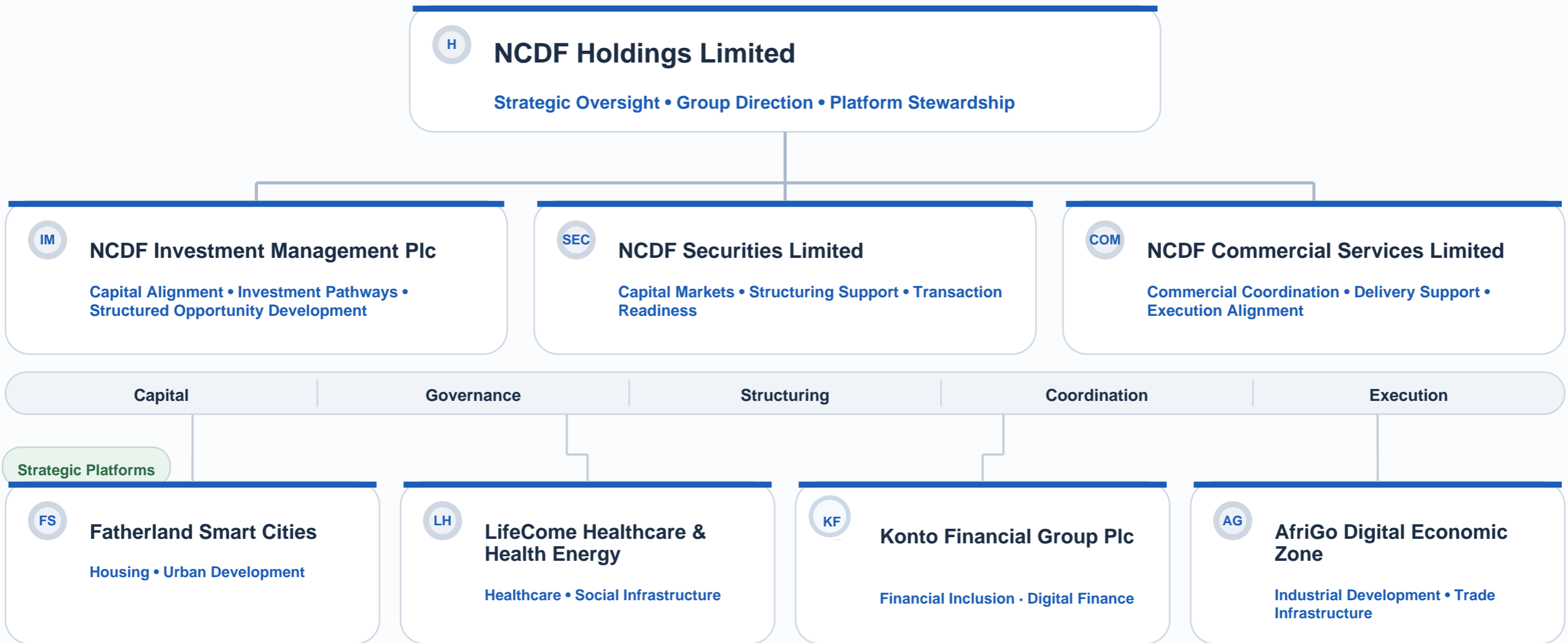
NCDF Ecosystem Overview

Core Entities

The institutional core provides the structure through which the wider ecosystem is directed, organised, and supported.

NCDF Holdings Limited

Provides strategic oversight, group direction, and ecosystem stewardship.

NCDF Investment Management Plc

Supports capital alignment, investment pathways, and structured opportunity development.

NCDF Securities Limited

Supports capital-markets readiness, structuring capability, and transaction-facing pathways.

NCDF Commercial Services Limited

Supports commercial coordination, delivery alignment, and execution support across the wider estate.

Institutional Logic

How the Ecosystem Works in Practice

The ecosystem should be understood as a connected sequence.

1 Strategic direction is set

Oversight begins at group level.

2 Opportunities are aligned

The right institutional route is identified.

3 Capital and structuring are connected

Relevant support pathways are activated.

4 Platforms provide sector pathways

Housing, healthcare, financial inclusion, and industrial development are advanced through platform logic.

5 Execution is supported within the wider system

The ecosystem connects advancement with stronger coordination and institutional discipline.
